





- NES support for equivalence applications is open until 31 March 2022 OR earlier if fund is exhausted. Covers applications to AHCS, ACS and IBMS for STP/clinical scientist portfolio assessment, and IBMS assessment of undergraduate degrees for Biomedical Scientist recognition.

- Good Scientific Practice was revised on 1st September 2021
- Benefits of Equivalence include "future-proofing", demonstrating attainment of an external standard, becoming statutory registered
- Put patients at the centre of your practice, even if your role is not patient-facing
- Be aware of all relevant legislation, the risks involved in working in healthcare environments, and approaches to risk management and mitigation to uphold the health and safety of all parties
- Comparability with STP programme is key; reasonable not to be strong in all areas additional strength in one will compensate for weaker areas... it is a judgement call
- Expect to expend effort... state registration is the goal and it is hard won!
- However, don't overthink it. Start with making a list of possible evidence and identify gaps. Follow the mapping templates and show how your evidence demonstrates the standard. Give yourself a deadline.
- You don't need too many pieces of evidence be concise but include the right pieces of evidence to demonstrate the standard in question
- Get help and speak to others who have done it recently

- Reflections
- CPD register
- Reference letter from colleague, or someone you have trained

Scientific Practice & Research Development and Innovation

- List of publications
- Audits
- Validations
- Grants/ projects

Clinical Practice

- List of courses/training
- Reflections/ ward rounds
- Audits

Clinical leadership

- Conferences, meetings, societies
- STEM/ public engagement
- Grants/ projects
